BACKGROUND 23 24 A. - c. The Division assessed a civil penalty in the amount of \$1,530 with \$765 suspended.
- G. The Division further identified that **O'BRIEN INSURANCE** did not have a Designated Responsible Licensed Producer (DRLP) on file, a violation of Alaska Statute (AS) 21.27.020(c)(3). Kay Isola's license expired December 31, 2023, for failure to renew, terminating the DRLP designation effective on the same date. The Division assessed an additional civil penalty in the amount of \$100 for the lack of DRLP for **O'BRIEN INSURANCE**. This fee has already been paid to the Division.
- H. Lastly, through correspondence with O'BRIEN INSURANCE use of a fictitious name not on the license was identified, a violation of AS 21.27.020(d). The Division assessed a civil penalty for using fictitious name "The Doctor's Agency" not listed in O'BRIEN INSURANCE license from 2018 in the amount of \$1,000 per year for six years for a total civil penalty of \$6,000 with \$400 waived as fees already paid to the Division.
- I. On May 16, 2024, the Division sent correspondence a proposed settlement to O'BRIEN INSURANCE assessing the civil penalties in paragraph F.c., G & H.
- J. On May 21, 2024, O'BRIEN INSURANCE accepted the proposed agreement.
- II. TERMS OF AGREEMENT

O'BRIEN INSURANCE SERVICES, INC Stipulated Agreement and Order D24-16 A. On December 2021, one (1) policy was transacted during a period when their license was expired and were in violation of AS 21.27.010 which subjects **O'BRIEN INSURANCE** to civil penalties. AS 21.27.440(a) provides that "in addition to any other penalties provided by law, a person that the director determines under AS 21.06.170-21.06.240 has violated the provisions of this chapter is subject to (1) a civil penalty equal to the compensation promised, paid, or to be paid, directly or indirectly, to a person in regard to each violation; (2) either a civil penalty of not more than \$10,000 for each violation or a civil penalty of not more than \$25,000 for each violation if the director determines that the person willfully violated the provisions of this chapter; and (3) denial, nonrenewal, suspension, or revocation of a license." The director has the latitude to impose civil penalties against a person who has violated Alaska's insurance laws.

- B. **O'BRIEN INSURANCE** agrees to pay the civil penalty for unlicensed activity in the amount of \$1530 for activity that occurred during a period when their license was expired with \$765 suspended. The unsuspended portion of \$765 must be received by the Division within 30 days of the signature finalizing this agreement.
- C. **O'BRIEN INSURANCE** further agrees to pay \$5,600 for using fictitious name with a total of \$6,365 and must be received by the Division within 30 days of the signature finalizing this agreement.
