# STIPULATED AGREEMENT AND ORDER

The State of Alaska Department of Commerce, Community, and Economic

Development, Division of Insurance (Division), COLLECTOR'S RISK INC

(COLLECTOR'S RISK) the producer in this case, stipulate and agree to the following:

# I. BACKGROUND

A. On November 13, 2020, **COLLECTOR'S RISK** received their initial Insurance Producer license with Casualty, and Property lines of authority, license number 3001080980, authorizing **COLLECTOR'S RISK** to transact insurance business in Alaska. This license expires in November 13 of odd numbered years.

B. On September 7, October 6, and November 8, 2022, the Division provided COLLECTOR'S RISK renewal notices informing of the impending expiration date of November 13, 2022.

- C. On November 13, 2022, **COLLECTOR'S RISK's** license expired for failure to renew.
- D. On December 6, 2022, expiration notice was provided to
   COLLECTOR'S RISK informing that the firm's license had expired for failure to renew.
- E. On December 20, 2023, **COLLECTOR'S RISK** applied to reinstate its license.
- F. On January 25, 2024, COLLECTOR'S RISK's license was reinstated.
- G. During an internal audit the Division discovered that COLLECTOR'S
   RISK issued policies between November 13, 2022, and January 25, 2024, without a valid license.
- H. On February 13, 2024, the Division sent correspondence to
   COLLECTOR'S RISK regarding the unlicensed activity and requested
   the firm provide a Business Transaction Form (BTF).
- I. On February 29, 2024, Gregory Brown Authorized Submitter for COLLERCTOR'S RISK provided the BTF form in support of its reinstatement application. Upon review of the BTF, it was revealed two (2) policies were sold between November 13, 2022, and January 25, 2024, resulting in \$2,002.76 commission during a period when their license was expired.

COLLECTOR'S RISK INC Stipulated Agreement and Order D24-21 J. On June 6, 2024, the Division sent correspondence a proposed settlement to COLLECTOR'S RISK assessing a civil penalty in the amount of \$2,002 with \$1,001 suspended. The unsuspended penalty of \$1,001 is payable to the Division.

K. On June 11, 2024, COLLECTOR'S RISK accepted the proposed agreement.

# II. TERMS OF AGREEMENT

A. Between November 13, 2022, and January 25, 2024, two (2) total policies were transacted prior to the license reinstatement date of January 25, 2024, and were in violation of Alaska Statute (AS) 21.27.010 which subjects **COLLECTOR'S RISK** to civil penalties. AS 21.27.440(a) provides that "in addition to any other penalties provided by law, a person that the director determines under AS 21.06.170-21.06.240 has violated the provisions of this chapter is subject to (1) a civil penalty equal to the compensation promised, paid, or to be paid, directly or indirectly, to a person in regard to each violation; (2) either a civil penalty of not more than \$10,000 for each violation or a civil penalty of not more than \$25,000 for each violation if the director determines that the person willfully violated the provisions of this chapter; and (3) denial, nonrenewal, suspension, or revocation of a license." The director has the latitude to impose civil penalties against a person who has violated Alaska's insurance laws.
