21.06.170-21.06.240 has violated the provisions of this chapter is subject to (1) a civil penalty equal to the compensation promised, paid, or to be paid, directly or indirectly, to a person in regard to each violation; (2) either a civil penalty of not more than \$10,000 for each violation or a civil penalty of not more than \$25,000 for each violation if the director determines that the person willfully violated the provisions of this chapter; and (3) denial, nonrenewal, suspension, or revocation of a license." The director has the latitude to impose civil penalties against a person who has violated Alaska's insurance laws.

- B. AMERICAN MUTUAL further agrees to pay the civil penalty in the amount of \$1099 for activity that occurred prior to the issuance of the firms license with \$549 suspended. The unsuspended portion of \$550 must be received by the Division within 30 days of the signature finalizing this agreement.
