# ACCUSATION AND ORDER OF REVOCATION

- 1. On August 16, 2023, RAQUEL MERCEDES GARCIA (GARCIA), domiciled in the State of Arizona applied for Insurance Producer License with the Alaska Department of Commerce, Community and Economic Development, Division of Insurance (Division) to transact the business of Life insurance. The Division issued license number 3002666810 and has an expiration date of March 31 on even numbered years.
- 2. The Division received notice from National Insurance Producer Registry (NIPR) with an attached transaction log indicating GARCIA has unsettled payment of \$75.00 for State licensing fee and \$5.60 for transaction fee totaling \$80.60 in unpaid license fees.

3. On February 12, 2024, the Division sent notice to **GARCIA** informing her of her unpaid license fees and gave **GARCIA** until March 1, 2024, to respond. No payment was received by the Division.

- 4. On March 1, 2024, the Division provided **GARCIA** a second notice informing of the unpaid license fees. No response was received.
- 5. Pursuant to Alaska Statute (AS) 21.27.040 which states that "(f) If, through inaction, an applicant fails to complete the application process, the applicant's application filed with the director under (a) of this section is considered withdrawn..."
- 6. AS 21.27.410(a)(8) dictates, "the conduct of affairs under a license if the licensee exhibits conduct considered by the director to reflect incompetence or untrustworthiness, or to be a source of potential injury and loss to the public;"
- 7. AS 21.27.010(a) also states in part that "...a person may not act as or represent to be an insurance producer, managing general agent, or surplus lines broker in this state or relative to a subject resident, located, or to be performed in this state unless licensed under this chapter."
- 8. Further, AS 21.27.440(a) provides that "in addition to any other penalties provided by law, a person that the director of the division (director) determines under AS 21.06.170-21.06.240 has violated the provisions of this chapter is subject to (1) a civil penalty equal to the compensation promised, paid, or to be paid, directly or indirectly, to a person in regard to each violation; (2) either a civil penalty of not more than \$10,000 for each
