STIPULATED AGREEMENT AND ORDER

The Division of Insurance, Department of Commerce and Economic Development (division) and Paul L. White (White), the licensee in this case, stipulate and agree that the unlicensed activity that occurred during the time White's individual in a firm license #2785 was in lapse status is resolved as follows:

1. White admits that while his insurance license was in lapse status, from September 4, 1997 through September 22, 1997, he transacted the business of insurance and received commissions in the amount of \$410.40, in violation of AS 21.27.380(b). Prior to this instance, White has never allowed his Alaska insurance license to lapse and, to the division's knowledge, he has not engaged in unlicensed activity.

2. Under AS 21.27.420(c), the division agrees to reinstate White's insurance license subject to the condition that White pay a civil penalty of \$410.40, as allowed under AS 21.27.440(a), which is payable no later than twelve months from the date this agreement and order is signed by the director.

3. By signing this agreement, White understands and agrees that any failure to comply with the conditions of this agreement will be grounds to revoke, suspend, or non-renew Alaska insurance license #2785.


