STIPULATED AGREEMENT AND ORDER

The Division of Insurance, Department of Commerce and Economic Development (division) and Jatana Willard San Pedro (San Pedro), the licensee in this case, stipulate and agree that the failure to timely renew her license #15077 and the unlicensed activity that occurred during the time the license was in lapse status are resolved as follows:

1. San Pedro admits that while her individual in a firm insurance license was in lapse status, from May 20, 1998 through June 22, 1998, she transacted the business of insurance and received commissions in the amount of \$163.52, in violation of AS 21.27.380(b). Prior to this instance, San Pedro had never allowed her Alaska insurance license to lapse and, to the division's knowledge, she had not engaged in unlicensed activity.

2. Under AS 21.27.420(c), the division agrees to reinstate San Pedro's insurance license subject to the condition that she pay a civil penalty of \$163.52, as allowed






