STIPULATED AGREEMENT AND ORDER

The Division of Insurance (division) and Karen S. Pierce (Ms. Pierce), the licensee in this case, stipulate and agree that the failure to timely renew license #10678 and the unlicensed activity that occurred during the time the license was in lapse status are resolved as follows:

- Ms. Pierce admits that, between November 15, 2002 and February 7,
 2003, she transacted the business of insurance, in violation of AS 21.27.380.
- Prior to this instance, to the division's knowledge, Ms. Pierce had not engaged in unlicensed activity.
- 3. Ms. Pierce agrees to pay a civil penalty under AS 21.27.440 of \$715 for the unlicensed activity that occurred between November 15, 2002 and February 7, 2003, with \$215 suspended. The unsuspended portion of the penalty is payable at the time the director signs the order approving this agreement.
- In the event Ms. Pierce violates the insurance code or applicable
 regulations during the next two years, the suspended portion of the fine referenced in paragraph
