## STIPULATED AGREEMENT AND ORDER

The Division of Insurance (division) and Molly M. Brown (Ms. Brown), the licensee in this case, stipulate and agree that the failure to timely renew license #22553 and the unlicensed activity that occurred during the time the license was in lapse status are resolved as follows:

- Ms. Brown admits that, between August 10, 2002 and February 26, 2003, she transacted the business of insurance, in violation of AS 21.27.380.
- Prior to this instance, to the division's knowledge, Ms. Brown had not engaged in unlicensed activity.
- 3. Ms. Brown agrees to pay a civil penalty under AS 21.27.440 of \$3,885.57 for the unlicensed activity that occurred between August 10, 2002 and February 26, 2003, with \$2,000 suspended. The unsuspended portion of the penalty is payable at the time the director signs the order approving this agreement.
- In the event Ms. Brown violates the insurance code or applicable
   regulations during the next two years, the suspended portion of the fine referenced in paragraph

- 6. Ms. Brown understands that this agreement is not binding on the parties unless and until the director signs the order approving the agreement.
