### STIPULATED AGREEMENT AND ORDER

The Division of Insurance (division) and William E. Hunsuck (Mr. Hunsuck), the licensee in this case, stipulate and agree that the failure to timely renew license #18477 and the unlicensed activity that occurred during the time the license was in lapse status are resolved as follows:

- Mr. Hunsuck admits that, between September 19, 2003 and September
   24, 2003, he transacted the business of insurance, in violation of AS 21.27.380.
- Prior to this instance, to the division's knowledge, Mr. Hunsuck had not engaged in unlicensed activity.
- 3. Mr. Hunsuck agrees to pay a civil penalty under AS 21.27.440 of \$1,000 for the unlicensed activity that occurred between September 19, 2003 and September 24, 2003, with \$500 suspended. The unsuspended portion of the penalty is payable at the time the director signs the order approving this agreement.
- 4. In the event Mr. Hunsuck violates the insurance code or applicable regulations during the next two years, the suspended portion of the fine referenced in
