STIPULATED AGREEMENT AND ORDER

The Division of Insurance (division) and David A. Snow (Mr. Snow), the licensee in this case, stipulate and agree that the failure to timely renew license #17857 and the unlicensed activity that occurred during the time the license was in lapse status are resolved as follows:

1. Mr. Snow admits that, between October 15, 2004 and December 29, 2004, he transacted the business of insurance, in violation of AS 21.27.380.
2. Prior to this instance, to the division's knowledge, Mr. Snow had not engaged in unlicensed activity.
3. Mr. Snow agrees to pay a civil penalty under AS 21.27.440 of \$3,915.42 for the unlicensed activity that occurred between October 15, 2004 and December 29, 2004, with \$2,500 suspended. The unsuspended portion of the penalty is payable within six months of the date Mr. Snow is notified that the director has sign the order approving this agreement.
4. In the event Mr. Snow violates the insurance code or applicable regulations during the next two years, the suspended portion of the fine referenced in

paragraph 3 will be reinstated. Mr. Snow also will be subject to any and all sanctions authorized by the insurance code including imposition of additional fines or penalties.

5. By signing this agreement, Mr. Snow understands and agrees that any failure to comply with the conditions of this agreement will be grounds to revoke, suspend, or not renew producer license #17857.


6. Mr. Snow understands that this agreement is not binding on the parties unless and until the director signs the order approving the agreement.




