STIPULATED AGREEMENT AND ORDER

The Division of Insurance (division) and AirSure Limited (Anchorage, AK) (AirSure), the licensee in this case, stipulate and agree that the failure to timely renew license #28273 and the unlicensed activity that occurred during the time the license was in lapse status are resolved as follows:

1. AirSure admits that, between July 2, 2004 and December 22, 2004, the firm branch transacted the business of insurance, in violation of AS 21.27.380.
2. Prior to this instance, to the division's knowledge, AirSure had not engaged in unlicensed activity.
3. AirSure agrees to pay a civil penalty under AS 21.27.440 of \$3,381.25 for the unlicensed activity that occurred between July 2, 2004 and December 22, 2004, with \$1,381.25 suspended. The unsuspended portion of the penalty is payable at the time the director signs the order approving this agreement.
4. In the event AirSure or its Compliance Officer, William B. Behan, violates the insurance code or applicable regulations during the next two years, the suspended

5. By signing this agreement, AirSure understands and agrees that any failure to comply with the conditions of this agreement will be grounds to revoke, suspend, or not renew producer license #28273.

6. AirSure understands that this agreement is not binding on the parties unless and until the director signs the order approving the agreement.
