10 STIPULATED AGREEMENT AND ORDER

11 The Division of Insurance (division) and Susan K. Donovan (Ms. Donovan), the
12 licensee in this case, stipulate and agree that the failure to reinstate license #19722 before the
13 licensee performed adjusting activities and the unlicensed activity that occurred are resolved as
14 follows:

- 15 1. Ms. Donovan admits that between October 15, 2004 and December 7,
16 2004, before her Alaska individual adjuster license was reinstated, she transacted the business
17 of insurance, in violation of AS 21.27.380(b), for which she received no commissions. The
18 division received Ms. Donovan's application for reinstatement of her individual insurance
19 adjuster license on October 1, 2004 and reinstated it effective December 27, 2004.
- 20 2. Prior to this instance, to the division's knowledge, Ms. Donovan has not
21 engaged in unlicensed activity or otherwise violated the insurance code.
- 22 3. Ms. Donovan agrees to pay a civil penalty under AS 21.27.440(a) of
23 \$3,300 for the unlicensed activity that occurred between October 15, 2004 and December 7,

1 2004, with \$2,000 suspended. The unsuspended portion of the penalty is due within six months
2 of the date the director signs the order approving this agreement.

3 4. In the event Ms. Donovan violates the insurance code or applicable
4 regulations during the next two years, the suspended portion of the fine referenced in paragraph
5 3 will be reinstated. Ms. Donovan also will be subject to any and all sanctions authorized by
6 the insurance code including imposition of additional fines or penalties.

7
8 5. By signing this agreement, Ms. Donovan understands and agrees that any
9 failure to comply with the conditions of this agreement will be grounds to revoke, suspend, or
10 not renew Alaska insurance license #19722.

11 6. Ms. Donovan understands that this agreement is not binding on the
12 parties unless and until the director signs the order approving the agreement.




