STIPULATED AGREEMENT AND ORDER

The Division of Insurance (division) and Robert T. Fudge, II (Mr. Fudge), the licensee in this matter, stipulate and agree to the following:

I. BACKGROUND

- A. On or about March 12, 2008, Mr. Fudge submitted an application to the division for an individual in a firm limited lines insurance license.
- B. As Mr. Fudge's application was complete and his answers on the application did not indicate any reason not to issue him a license, the division issued license number 69846, effective March 20, 2008.
- C. Subsequently, the division received a criminal history report that revealed that Mr. Fudge had a misdemeanor conviction in 1984 and misdemeanor case in 1998, both of which he should have reported on his initial application.

II. TERMS OF AGREEMENT

1. Mr. Fudge agrees to pay a civil penalty under AS 21.27.440(a) in the amount of \$750, with \$400 suspended. The civil penalty is payable at the time Mr. Fudge is notified that the director has signed the order approving this agreement.

1 2. In the event Mr. Fudge violates the insurance code or applicable
2 regulations during the next two years, the suspended portion of the fine referenced in
3 paragraph 1 will be reinstated. Mr. Fudge also will be subject to any and all sanctions
4 authorized by the insurance code including imposition of additional fines or penalties.

6 3. By signing this agreement, Mr. Fudge understands and agrees that any
7 failure to comply with the terms of this agreement may be grounds to revoke, further suspend,
8 or non-renew Alaska insurance license number 69846.

10 4. Mr. Fudge understands that this agreement is not binding on the parties
11 unless and until the director signs the order approving the agreement.




