STIPULATED AGREEMENT AND ORDER

The Division of Insurance (division) and Fred Adkerson, Inc., dba Fred's Bail Bonding (Fred's), the licensee in this case, stipulate and agree to the following:

I. BACKGROUND

- A. The division conducted an examination of Fred's and issued Examination Report and Order No. FE 09-01, which was sent to Fred's on or about December 9, 2009. The report listed seven findings and recommendations that need to be implemented to ensure that Fred's fully complies with Alaska insurance law.
- B. The report listed five areas where Fred's was out of compliance with Alaska's insurance laws, which makes Fred's subject to civil penalties under AS 21.27.440

II. TERMS OF AGREEMENT

1. Fred's agrees to pay a civil penalty under AS 21.27.440 in the amount of \$50,000, with \$20,000 suspended. The unsuspended penalty is payable within three months of the date that Fred's is notified that the director has signed the order approving this agreement.

	2.	In the event Fred's violates the insurance code or applicable regulations
during the r	next two	years, the suspended portion of the fine referenced in paragraph 1 will be
reinstated.	Fred's a	so will be subject to any and all sanctions authorized by the insurance code
including in	npositio	n of additional fines or penalties.

- 3. By signing this agreement, Fred's understands and agrees that any failure to comply with the conditions of this agreement will be grounds to revoke, suspend, or not renew Alaska insurance license #7986.
- 7. Fred's understands that this agreement is not binding on the parties unless and until the director signs the order approving the agreement.
