STIPULATED AGREEMENT AND ORDER

The Division of Insurance (division) and Risk Services Corp. (RSC) and Georgianna Stump (Ms. Stump), the licensees in this matter, stipulate and agree that the unlicensed activity that occurred during the time RSC and Ms. Stump were not appropriately licensed is resolved as follows:

- 1. On or about July 31, 2007, the division sent RSC a renewal application for firm license #35888. On November 2, 2007, the division notified RSC that its insurance producer license had lapsed for failure to renew. Ms. Stump was also notified that, because of the firm lapse, she needed to take action to maintain her license #41864 in good standing.

 Since the division received nothing from Ms. Stump, her license also lapsed on March 14, 2008.
- 2. It was not until November 2009 that the division received applications to reinstate RSC and Ms. Stump's licenses and, after all requirements for licensure were received, the division reinstated both licenses effective December 8, 2009.



3.	As required by the division, Ms. Stump submitted a notarized statement
indicating whether bu	siness was transacted when the firm and Ms. Stump were not
appropriately licensed	. The statement listed several insurance transactions that occurred
between November 2,	2007 and November 19, 2009.

- 4. RSC and Ms. Stump agree to pay a civil penalty under AS 21.27.440(a) in the amount of \$13,177.54 for the unlicensed activity that occurred between November 2, 2007 and November 19, 2009, with \$7,177.54 suspended. The civil penalty is payable within six months from the time RSC and Ms. Stump are notified that the director has signed the order approving this agreement.
- 5. In the event RSC and Ms. Stump violate the Alaska insurance laws during the next two years, the suspended portion of the penalty referenced in paragraph 4 will be reinstated. RSC and Ms. Stump also will be subject to any and all sanctions authorized by the insurance laws including imposition of additional penalties.
- 6. By signing this agreement, RSC and Ms. Stump understand and agree that any failure to comply with the terms of this agreement may be grounds to revoke, suspend, or non-renew Alaska insurance licenses #35888 and #41864.
- 7. RSC and Ms. Stump understand that this agreement is not binding on the parties unless and until the director signs the order approving the agreement.
