STIPULATED AGREEMENT AND ORDER

The Division of Insurance (division) and Melissa J. Haxton (Ms. Haxton), the licensee in this case, stipulate and agree that the unlicensed activity that occurred during the time license #60408 was in lapse status is resolved as follows:

- 1. On June 24, 2011, the division sent Ms. Haxton a license renewal application to the address on file for her. The renewal application stated "Renewal form and all other required materials must be received by the division by: 08/13/11." On August 19, 2011, the division notified Ms. Haxton that her insurance producer license had lapsed for failure to renew.
- 2. Also, on August 19, 2011, the division received Ms. Haxton's license renewal application. As required by the division, Ms. Haxton then submitted a notarized statement indicating whether business had been transacted while her license was in lapse status. The requirements necessary to reinstate her license were not completed until October 2011 and the division reinstated her license effective October 11, 2011. The statement indicated that several insurance transactions occurred between August 19, 2011 and August 29, 2011 while

- Ms. Haxton agrees to pay a civil penalty under AS 21.27.440(a) of \$700 for the unlicensed activity that occurred between August 19, 2011 and August 29, 2011, with \$350 suspended. The unsuspended portion of the penalty is payable at the time Ms. Haxton is
- In the event Ms. Haxton violates Alaska's insurance laws during the next two years, the suspended portion of the penalty referenced in paragraph 4 will be reinstated. Ms. Haxton also will be subject to any and all sanctions authorized by the insurance code
- By signing this agreement, Ms. Haxton understands and agrees that any failure to comply with the conditions of this agreement will be grounds to revoke, suspend, or not renew Alaska insurance license #60408.
- Ms. Haxton understands that this agreement is not binding on the parties 7. unless and until the director signs the order approving the agreement.
