STIPULATED AGREEMENT AND ORDER

The Division of Insurance (division) and Denali Alaskan Insurance, LLC (Denali), the licensee in this case, stipulate and agree to the following:

I. **BACKGROUND**

- Denali holds surplus lines broker and firm insurance producer license A. #27950.
- В. Under AS 21.06.130, on January 11 through 13, 2012, the division performed a limited and targeted premium tax audit of Denali covering the period of January 1, 2009 through December 31, 2010. The audit was completed and a report and order approving the report were issued May 4, 2012 under number TA 12-02. Both were sent to Denali on May 8, 2012.
- C. The audit report identified 67 violations of AS 21.27 and AS 21.34 that are within the control of Denali to correct in order to comply with Alaska insurance laws.
- D. The violations of AS 21.27 and AS 21.34 subject Denali to civil penalties under AS 21.27.440 and AS 21.34.230.

II. TERMS OF AGREEMENT

- 1. The division agrees that any future audit performed on Denali related hereto will cover calendar years starting with 2013 or later but not any year before 2013.
- 2. Denali agrees to pay a civil penalty under AS 21.27.440 and AS 21.34.230 in the amount of \$50,000, with \$25,000 suspended. The unsuspended penalty is payable within three months from the time that Denali is notified that the director has signed the order approving this agreement.
- 3. In the event Denali violates the Alaska insurance laws during the next two calendar years, the suspended portion of the penalty referenced in paragraph 2 will be reinstated. Denali also will be subject to any and all sanctions authorized by the insurance laws including imposition of additional penalties.
- 4. By signing this agreement, Denali understands and agrees that any failure to comply with the terms of this agreement may be grounds to revoke, suspend, or non-renew Alaska surplus lines broker and firm insurance producer license #27950.
- 5. Denali understands that this agreement is not binding on the parties unless and until the director signs the order approving the agreement.
