**AMENDED ORDER WITHDRAWING APPROVAL OF MCE REPORT AND
TERMINATING MCE P-07-01**

1. Ms. Lashbrook obtained Alaska insurance producer license number 27347 on April 1, 2002.

2. The division conducted a market conduct examination of Sandra J. Lashbrook d/b/a Senior Adults Money Coaching, LLC a/k/a Conservative Retirement Coaching from February 12, 2007 to June 8, 2007.

3. The examination resulted in report number MCE P-07-01 dated August 10, 2007 which was approved by the deputy director on December 14, 2007.

4. On March 11, 2008 counsel for Ms. Lashbrook timely filed a request for an administrative hearing and appeal of the order of the deputy director approving MCE P-07-01.

5. After the director assigned a hearing officer to this matter, extensive motion practice ensued. Since June 2009, several substantive motions have been pending the hearing officer's decision. On December 1, 2009 the hearing officer resigned, leaving the pending motions undecided, without appointing a successor

hearing officer, and without setting a hearing date. All attempts to settle this matter since December 1, 2009 have failed.


6. Because of the passage of time, this matter is becoming stale. Memories of the witnesses are fading. Any further litigation will result in delay, additional consumption of limited division resources, and uncertainty.

7. For the reasons cited above I conclude it is prudent to withdraw approval of the MCE report and terminate MCE P-07-01. Therefore,

IT IS ORDERED:

The order I signed on July 15, 2010 is rescinded and this amended order takes its place. Under AS 21.06.080 and AS 21.06.140 approval of MCE report P-07-01 is withdrawn and MCE P-07-01 is terminated without findings. All work papers, documents and reports that are part of MCE P-07-01 shall remain confidential and are not to be disclosed by the parties pursuant to AS 21.06.150(g).
