STATEMENT OF ISSUES

Linda S. Hall, Director, Division of Insurance (division), Department of Community and Economic Development, State of Alaska, states:

- On or about March 24, 2003, the division received from Near North
 Insurance Brokerage, Inc. (Near North) an application for the renewal of its firm insurance
 producer and surplus lines broker license number 12771. Michael Segal (Mr. Segal) is listed as
 the compliance officer on the renewal application, and he signed the application in that capacity
 on March 10, 2003.
- Directly above the signature line on the application that Mr. Segal signed is the following statement.

As the licensed compliance officer of the firm, I declare that we are in full compliance with the Alaska Insurance statutes and regulations applicable to our license. I further certify that if, within the last license period, the firm or any Alaska licensed individual affiliated with the firm received a suspension, revocation, or any disciplinary action by any other jurisdiction or charged or convicted of a misdemeanor or felony, a complete explanation is ATTACHED. I HEREBY AUTHORIZE AND CONSENT TO ANY INVESTIGATION

No explanation regarding any disciplinary action or any charges was attached to this renewal application.

- In reviewing records of disciplinary action in other jurisdictions, the following actions were revealed:
- a. Effective July 17, 2002, California issued an Order of Immediate Suspension of Mr. Segal's non-resident insurance licenses. The reason listed for California's action was "criminal proceedings."
- Effective July 17, 2001, Iowa fined Mr. Segal \$200 for his failure to meet continuing education requirements.
- c. Effective November 13, 2002, Kentucky suspended Mr.Segal's nonresident license, stating the reason for its action as "demonstrated lack of fitness or trustworthiness, criminal proceedings."
- 4. The division also became aware that a federal indictment was issued against Mr. Segal in Illinois on February 14, 2002 for a violation of Title 18, U.S.C., Sections 1033(a)(1) and 2. No information regarding or explanation of this criminal charge was given by Mr. Segal with Near North's license renewal application.
- 5. On April 4, 2003, by certified mail, the division issued a Statement of Issues to Mr. Segal in Case No. LD 03-04 denying his application for the renewal of his individual in a firm insurance producer and surplus lines broker license number 12772. The division denied his application because of Mr. Segal's failure to provide the division with

that his licenses have been suspended in other jurisdictions, and the fact that he signed a statement declaring that he was in compliance with Alaska insurance law when he was not.

- 6. None of the information itemized above was provided with Near North's application for renewal, as it should have been. Mr. Segal's failure to provide this information on the Near North application demonstrates untrustworthiness and is a basis to deny renewal of a license under AS 21.27.025(c) and 21.27.410(a)(2), (8), and (14).
- 7. Mr. Segal is still licensed in his home state of Illinois and, therefore, is still acting on behalf of Near North. That fact and the division's denial of Mr. Segal's license are bases to deny renewal of Near North's license under AS 21.27.140(b) and 21.27.410(b).
- Pursuant to AS 21.27.025(c), 21.27.140(b), and 21.27.410(a)(2), (8), (14)
 and (b), the application of Near North for renewal of its firm insurance producer and surplus
 lines broker license number 12771 is hereby DENIED.
