b. Smith will pay a civil fine of \$500 with \$250 suspended.

3. In the event Smith violates the insurance code or applicable regulations during the next two years, the suspended portion of the fine referenced in paragraph 2b will be reinstated. Smith also will be subject to any and all sanctions authorized by statute including imposition of additional fines or penalties.

4. By signing this agreement, Smith understands and agrees that any failure to comply with the conditions of this agreement will be grounds to revoke, suspend, or non-renew his Alaska insurance license.
