STATEMENT OF ISSUES

Marianne K. Burke, Director, Division of Insurance (division),

Department of Commerce and Economic Development, State of Alaska, states:

- On or about July 8, 1996, the division received an application for a firm insurance license from MGA Bonding and Assurance Services, Inc. (MGA), an Arizona corporation.
- The application designates Don Joseph Snyder as the Compliance
 Officer and Manager of MGA. It also lists Joel Wisse and Buck Ford as
 President and Vice President, respectively, of the corporation.
- 3. A background investigation of the application revealed that the following administrative actions have occurred since MGA's application was first submitted to the division:
- a. On or about August 13, 1996, the State of Washington issued Order to Cease and Desist No. D.96-53 against several entities including

MGA with David M. Novick (Novick), President, and Joel S. Wisse (Wisse), Vice President, for unlicensed activity in Washington.

b. On or about August 5, 1996, the Commonwealth of Virginia issued a Judgment Order in Case No. INS950197 against Emerald Financial Services, Inc. (Emerald) and David M. Novick and Joel S. Wisse as Attorneys-in-Fact for Emerald Financial Services, Inc. for unlicensed activity in Virginia. The order permanently enjoins Emerald from transacting the business of insurance in Virginia and requires Novick and Wisse to cease and desist from unlicensed insurance activity in Virginia. This order originated from action initiated by the Commonwealth by order dated March 15, 1996.

- c. On or about October 7, 1996, the State of Oregon issued a Stipulation and Final Order in Case No. INS 96-09-025 regarding MGA for unlicensed activity in Oregon.
- 4. On the application received by the division, MGA represents that Joel Wisse is President, Buck Ford is Vice President and Don Snyder is an officer of the corporation. However, the division has learned from the corporations office of the State of Arizona, the state in which MGA is incorporated, that this information is not correct. According to the State of Arizona, David M. Novick is in fact the President, Joel Wisse is the Vice President, Secretary, and Treasurer of MGA. Don Snyder is not identified as an officer of the corporation. Therefore, MGA's responses on the application misrepresent the status of officers for MGA and Snyder's eligibilty for designation as a compliance officer for the firm.

unlicensed activity in those states demonstrates untrustworthiness and/or that
MGA and its manager are not qualified for a license and are grounds to deny
issuance of a license under AS $21.27.020(a)$ -(c) and $21.27.410(a)$ and (b). The
misrepresentations on the application regarding the status of corporate officers
and the designated compliance officer are further grounds to deny issuance of the
license under AS 21.27.040(a). Failure to designate a licensed officer as manager
or compliance officer for the firm also is a ground to deny issuance of a firm
license under AS 21.27.020(c).

 Pursuant to AS 21.27.020(a)-(c), 21.27.040, and 21.27.410, the application of MGA Bonding and Assurance Services, Inc. for a firm insurance license is hereby DENIED.
