WHEREAS, a Certificate of Authority to transact the business of insurance in the State of Alaska has been issued to PROTECTIVE NATIONAL INSURANCE COMPANY OF OMAHA, domiciled in Nebraska.

WHEREAS, the State of Nebraska has placed PROTECTIVE NATIONAL INSURANCE COMPANY OF OMAHA under an Order of Rehabilitation dated May 24,1991. The company remains in rehabilitation at the present time.

WHEREAS, the Certificate of Authority for PROTECTIVE
NATIONAL INSURANCE COMPANY OF OMAHA OF OMAHA, to transact the
business of insurance in the State of Alaska was suspended
effective September 13, 1991, and that suspension has been
continued to the present.

WHEREAS, the 1998 Annual Statement of PROTECTIVE NATIONAL INSURANCE COMPANY OF OMAHA showed a negative capital and

surplus as regards to Policyholders in the amount of The Alaska required minimum capital and surplus \$(26,119,376). ber AS 21.09.070(b) for the kinds of insurance authorized by the state of domicile for this insurer is \$5,250,000. results in an impairment of \$31,369,376.

It is hereby ordered pursuant to the provision of AS 21.09.150(c) that Certificate of Authority No F-1314 issued to PROTECTIVE NATIONAL INSURANCE COMPANY OF OMAHA to transact the business of insurance in the State of Alaska shall continue to be suspended for a period of one year unless terminated sooner as permitted by statute.

During the period of suspension, PROTECTIVE NATIONAL INSURANCE COMPANY OF OMAHA shall not solicit or write any new br renewal business in Alaska, but shall file the Annual Statement, pay fees and any taxes due as provided by AS 21.09.170(b).

It is further ordered that Certificate of Authority No. F-1314 will continue to be held in safekeeping by PROTECTIVE NATIONAL INSURANCE COMPANY OF OMAHA until such time as this Order of Suspension is lifted or is replaced by an Order of Revocation.
