SECURITY LIFE INSURANCE COMPANY**. The company remains under
the Order of Supervision at the present time.

WHEREAS, the Certificate of Authority for **AMERICAN
FINANCIAL SECURITY LIFE INSURANCE COMPANY**, to transact the
business of insurance in the State of Alaska was suspended
effective September 2, 1992.


It is hereby ordered pursuant to the provision of AS 21.09.150(c) that Certificate of Authority No F-0693 issued to **AMERICAN FINANCIAL SECURITY LIFE INSURANCE COMPANY** to transact the business of insurance in the State of Alaska shall be suspended for a period of one year unless terminated sooner as permitted by statute.

During the period of suspension, **AMERICAN FINANCIAL SECURITY LIFE INSURANCE COMPANY** shall not solicit or write any new business in Alaska, but shall file the Annual Statement, pay fees and any taxes due as provided by AS 21.09.170(b).

It is further ordered that Certificate of Authority No. F-0693 will continue to be held in safekeeping by **AMERICAN FINANCIAL SECURITY LIFE INSURANCE COMPANY** until such time as this Order of Suspension is lifted or is replaced by an Order of Revocation.
