WHEREAS, a Certificate of Authority to transact the business of insurance in the State of Alaska has been issued to UNIVERSE LIFE INSURANCE COMPANY, domiciled in Idaho.

WHEREAS, the State of Alaska suspended the Certificate of Authority of UNIVERSE LIFE INSURANCE COMPANY, effective February 26, 1996 for a period of one year for failing to maintain the minimum capital and surplus required by AS 21.09.070.

WHEREAS, on March 4, 1996, the Idaho Department of
Insurance and the UNIVERSE LIFE INSURANCE COMPANY agreed to
place the company under an Order of Rehabilitation in the
Fourth Judicial District of the State of Idaho, County of Ada.

WHEREAS, on December 4, 1998, the Idaho Department of Insurance issued an Order of Liquidation in the District Court of the Fourth Judicial District of the State of Idaho, in and

for the County of Ada which placed the UNIVERSE LIFE INSURANCE COMPANY into Liquidation.

WHEREAS, 21.09.140(a)(2) states that the director shall suspend or revoke an insurer's certificate of authority if the insurer no longer meets the requirements for the authority granted, on account of the insurer becoming impaired or insolvent or otherwise.

It is hereby ordered pursuant to the provision of AS 21.09.140(a)(2) Certificate of Authority No F-1036 issued to UNIVERSE LIFE INSURANCE COMPANY to transact the business of insurance in the State of Alaska shall continue to be suspended for a period of one year unless terminated sooner as permitted by statute.

During the period of suspension, UNIVERSE LIFE INSURANCE

COMPANY shall not solicit or write any new or renew business in

Alaska, but shall file the Annual Statement, pay fees and any

taxes due as provided by AS 21.09.170(b).

It is further ordered that Certificate of Authority No.

F-1036 will continue to be held at UNIVERSE LIFE INSURANCE

COMPANY until such time as this Order of Suspension is lifted or is replaced by an Order of Revocation.
