22 WHEREAS, a Certificate of Authority to transact the
23 business of insurance in the State of Alaska has been issued to

writing any business and began total runoff of its business.

WHEREAS, THE HOME INSURANCE COMPANY's 1998 Annual
Statement discloses continued deterioration of its financial
condition and operating results.

It is hereby ordered pursuant to the provision of AS
21.09.150(c) that Certificate of Authority No F-1034 issued to
THE HOME INSURANCE COMPANY to transact the business of
insurance in the State of Alaska shall continue to be suspended

for a period of one year unless terminated sooner as permitted by statute. Pursuant to AS 21.09.160(b), this suspension shall automatically suspend the authority of all its agents to act as agents of **THE HOME INSURANCE COMPANY** in this state.

During the period of suspension, **THE HOME INSURANCE COMPANY** shall not solicit or write any new or renewal business in Alaska, but shall file the Annual Statement, pay fees and any taxes due as provided by AS 21.09.170(b).

It is further ordered that Certificate of Authority No. F-1034 will continue to be held in safekeeping by **THE HOME INSURANCE COMPANY** until such time as this Order of Suspension is lifted or is replaced by an Order of Revocation.
