14 WHEREAS, a Certificate of Authority to transact the  
15 business of insurance in the State of Alaska has been issued to  
16 INTERNATIONAL INDEMNITY COMPANY, domiciled in Georgia.

17 WHEREAS, INTERNATIONAL INDEMNITY COMPANY has voluntarily  
18 consented to an Order of Rehabilitation on November 8, 2000.  
19 The company remains in rehabilitation at the present time.

20 WHEREAS, AS 21.09.140 (a) (2) states that the director  
21 shall suspend or revoke an insurer's certificate of authority  
22 if the insurer no longer meets the requirements for the  
23 authority granted, on account of becoming impaired or  
24 insolvent.

25 WHEREAS, AS 21.09.175 states that if the director  
26 determines that an insurer transacting business in this state  
is impaired or in imminent danger of becoming impaired the

1 director may order an insurer to limit or change the insurer's  
2 business practices.

3 It is hereby ordered, pursuant to the provision of AS  
4 21.09.140(a) that Certificate of Authority No F-1474 issued to  
5 **INTERNATIONAL INDEMNITY COMPANY** to transact the business of  
6 insurance in the state of Alaska shall be suspended for a  
7 period of one year unless terminated sooner as permitted by  
8 statute. Pursuant to AS 21.09.160(b), this suspension shall  
9 automatically suspend the authority of all its agents to act as  
10 agents of **INTERNATIONAL INDEMNITY COMPANY** in this state.

11 During the period of suspension, **INTERNATIONAL INDEMNITY**  
12 **COMPANY** shall not solicit or write any new business in Alaska,  
13 but shall file the Annual Statement, pay fees and any taxes due  
14 as provided by AS 21.09.170(b).

15 It is further ordered that Certificate of Authority No. F-  
16 1474 will continue to be held in safekeeping by **INTERNATIONAL**  
17 **INDEMNITY COMPANY** until such time as this Order of Suspension  
18 is lifted or is replaced by an Order of Revocation.
