WHEREAS, a Certificate of Authority to transact the business of insurance in the State of Alaska has been issued to AMERICAN BONDING COMPANY, domiciled in Arizona.

WHEREAS, the State of Arizona has placed AMERICAN BONDING COMPANY under an Order of Suspension dated August 25, 1994. The order was based upon the financial problems of its holding company, Pace American Group, Inc. On September 26, 1994, the Arizona Department of Insurance issued an order causing AMERICAN BONDING COMPANY to cease the transaction of all new and renewal surety business.

WHEREAS, the Superior Court for the State of Arizona, in and for the county of Maricopa, issued an Order for the Appointment of Receiver and Injunction for AMERICAN BONDING COMPANY on February 2, 1995. AMERICAN BONDING COMPANY is still under the order of receivership.

WHEREAS, the 1999 Annual Statement showed a negative capital and surplus as regards policyholders of \$1,868,975.

The Alaska required minimum capital and surplus as per

AS 21.09.070(b) for the kinds of insurance authorized by the state of domicile for this insurer is \$5,250,000. This results in an impairment of \$7,129,975.

WHEREAS, the Certificate of Authority for AMERICAN BONDING COMPANY, to transact the business of insurance in the State of Alaska was suspended effective October 14, 1994, and that suspension has been continued to the present.

It is hereby ordered, pursuant to the provision of AS 21.09.140(a) that Certificate of Authority No F-0823 issued to AMERICAN BONDING COMPANY to transact the business of insurance in the state of Alaska shall be suspended for a period of one year unless terminated sooner as permitted by statute. Pursuant to AS 21.09.160(b), this suspension shall automatically suspend the authority of all its agents to act as agents of AMERICAN BONDING COMPANY in this state.

During the period of suspension AMERICAN BONDING COMPANY shall not solicit or write any new business in Alaska, but shall file the Annual Statement, pay fees and any taxes due as provided by AS 21.09.170(b).

It is further ordered that Certificate of Authority No. F-\$23 will continue to be held in safekeeping by AMERICAN BONDING COMPANY until such time as this Order of Suspension is ifted or is replaced by an Order of Revocation.

This order is effective the 14th day of October 2000. Date this 29th day of September 2000.
