under an Order of Supervision by the New Hampshire Department
of Insurance on March 3, 1997.

7 It is further ordered that Certificate of Authority No.
8 F-1676 will continue to be held in safekeeping by **US**
9 **INTERNATIONAL REINSURANCE COMPANY** until such time as this
10 Order of Suspension is lifted or is replaced by an Order of
11 Revocation.
