WHEREAS, a Certificate of Authority to transact the business of insurance in the State of Alaska was issued to **RELiance SURETY COMPANY**, domiciled in the State of Delaware.

WHEREAS, the Commonwealth Court of Pennsylvania on May 29, 2001 placed Reliance Insurance Company (“Reliance”) into Rehabilitation.

WHEREAS, the Order of Rehabilitation states that, “All references to “Reliance” hereinafter shall include the former subsidiaries which were

7 **WHEREAS, RELIANCE SURETY COMPANY** failed to properly notify
8 the State of Alaska of the change in corporate structure which took place before
9 the issuance of the Order of Rehabilitation.

11 **WHEREAS, RELIANCE SURETY COMPANY** has failed to submit the
12 2000 annual statement due on March 1, 2001 under AS 21.09.200.
13

14 **IT IS HEREBY ORDERED**, pursuant to the provision of AS 21.09.140(a)
15 that Certificate of Authority No F- 8079 issued to **RELIANCE SURETY**
16 **COMPANY** to transact the business of insurance in the State of Alaska shall be
17 suspended for a period of one year unless terminated sooner as permitted by
18 statute. Pursuant to AS 21.09.160(b), this suspension shall automatically suspend
19 the authority of all its agents to act as agents of **RELIANCE SURETY**
20 **COMPANY** in this state.
21

22 **IT IS FURTHER ORDERED**, during the period of suspension,
23 **RELIANCE SURETY COMPANY** shall not solicit or write any new business
24 in Alaska, but shall file the Annual Statement, pay fees and any taxes due as
25 provided by AS 21.09.170(b).


27 **IT IS FURTHER ORDERED**, Certificate of Authority No. F-8079 will
