**WHEREAS**, the Quarterly Statement as of June 30, 2001 for  
**PENNSYLVANIA CASUALTY COMPANY** shows that the company fails to  
meet the minimum Capital and Surplus requirement of AS 21.09.070 for the kinds  
of insurance authorized.

**IT IS HEREBY ORDERED**, pursuant to the provision of AS 21.09.140  
(a) (2) that Certificate of Authority No F- 1073 issued to **PENNSYLVANIA  
CASUALTY COMPANY** to transact the business of insurance in the State of  
Alaska shall be suspended for a period of one year unless terminated sooner as  
permitted by statute. Pursuant to AS 21.09.160 (b), this suspension shall  
automatically suspend the authority of all its agents to act as agents of  
**PENNSYLVANIA CASUALTY COMPANY** in this state.

**IT IS FURTHER ORDERED**, during the period of suspension  
**PENNSYLVANIA CASUALTY COMPANY** shall not solicit or write any new  
business in Alaska, but shall file the Annual Statement, pay fees and any taxes  
due as provided by AS 21.09.170 (b).

**IT IS FURTHER ORDERED** that Certificate of Authority No. F- 1073  
will continue to be held in safekeeping by **PENNSYLVANIA CASUALTY  
COMPANY** until such time as this Order of Suspension is replaced by an order  
of Revocation or the Certificate of Authority is surrendered.
