
1 **IT IS HEREBY ORDERED**, pursuant to the provision of AS 21.09.150 (c)
2
3 that Certificate of Authority No F- 8490 issued to **CONNECTICUT SURETY**
4 **COMPANY** to transact the business of insurance in the State of Alaska shall be
5 suspended for a period of one year unless terminated sooner as permitted by
6 statute. Pursuant to AS 21.09.160 (b), this suspension shall automatically suspend
7 the authority of all its agents to act as agents of **CONNECTICUT SURETY**
8 **COMPANY** in this state.

10 **IT IS FURTHER ORDERED**, that during the period of suspension,
11 **CONNECTICUT SURETY COMPANY** shall not solicit or write any new
12 business in the State of Alaska, but shall file the Annual Statement, pay fees and
13 any taxes due as provided by AS 21.09.170(b).

15 **IT IS FURTHER ORDERED** that Certificate of Authority No. F-8490
16 will continue to be held in safekeeping by **CONNECTICUT SURETY**
17 **COMPANY** until such time as this Order of Suspension is replaced by an order
18 of Revocation or the Certificate of Authority is surrendered.
