any new business in Alaska, but shall file the Annual Statement, pay fees and any
taxes due as provided by AS 21.09.170 (b).

IT IS FURTHER ORDERED that Certificate of Authority No. F- 8108

will continue to be held in safekeeping by WESTERN INDEMNITY

INSURANCE COMPANY until such time as this Order of Suspension is replaced by an order of Revocation or the Certificate of Authority is surrendered.
