7                   **IT IS HEREBY ORDERED**, pursuant to the provision of AS 21.09.140 (a)  
8 (2) that Certificate of Authority No F- 1638 issued to **PROVIDENT**  
9 **AMERICAN LIFE AND HEALTH INSURANCE COMPANY** to transact the  
10 business of insurance in the State of Alaska shall be suspended for a period of one  
11 year unless terminated sooner as permitted by statute. Pursuant to AS 21.09.160  
12 (b), this suspension shall automatically suspend the authority of all its agents to  
13 act as agents of **PROVIDENT AMERICAN LIFE AND HEALTH**  
14 **INSURANCE COMPANY** in this state.

17                   **IT IS FURTHER ORDERED**, during the period of suspension,  
18 **PROVIDENT AMERICAN LIFE AND HEALTH INSURANCE**  
19 **COMPANY** shall not solicit or write any new business in Alaska, but shall file  
20 the Annual Statement, pay fees and any taxes due as provided by  
21 AS 21.09.170(b).


