
WHEREAS, **RAPID RESPONSE ROADSERVICE MOTOR CLUB, INC.**

IT IS HEREBY ORDERED, pursuant to the provision of AS
21.59.030 that Certificate of Authority No. F-8072 issued

the business of insurance in the State of Alaska shall be
revoked. Pursuant to AS 21.09.160(b), this revocation
shall automatically revoke the authority of all its agents
to act as agents of **RAPID RESPONSE ROADSERVICE MOTOR CLUB,
INC.** in this state.

IT IS FURTHER ORDERED, that Certificate of Authority
