**IT IS HEREBY ORDERED**, pursuant to the provision of AS 21.09.150 (c) that Certificate of Authority No F- 0350 issued to **CENTRAL NATIONAL INSURANCE COMPANY OF OMAHA** to transact the business of insurance in the State of Alaska shall be suspended for a period of one year unless terminated sooner as permitted by statute. Pursuant to AS 21.09.160 (b), this suspension shall automatically suspend the authority of all its agents to act as agents of **CENTRAL NATIONAL INSURANCE COMPANY OF OMAHA** in this state.
