WHEREAS, a Certificate of Authority to transact the business of insurance
in the State of Alaska was issued to **VESTA INSURANCE CORPORATION**,
domiciled in the State of Texas.

WHEREAS, the District Court of Travis County, Texas placed **VESTA**
INSURANCE CORPORATION under an Order of Rehabilitation appointing

1 the Insurance Commissioner of the State of Texas as receiver on June 28, 2006.

3 **WHEREAS**, based on said Order of Rehabilitation, the Certificate of
4 Authority issued to **VESTA INSURANCE CORPORATION** to transact the
5 business of insurance in the State of Alaska was suspended effective August 2,
6 2006 under the provisions of AS 21.09.150(c). That suspension has continued in
7 effect until the present.

11 **WHEREAS, VESTA INSURANCE CORPORATION** has failed to file
12 the 2006 and subsequent Annual Statements by the due date as required by AS
13 21.09.200 (a).

16 **WHEREAS, VESTA INSURANCE CORPORATION** has failed to pay
17 the 2007, 2008, 2009, and 2010 continuation fees by the June 30 due date as
18 required by AS 21.09.130(a).

21 **WHEREAS**, Certificate of Authority No. F-8023 issued to **VESTA**
22 **INSURANCE CORPORATION** to transact the business of insurance in the
23 State of Alaska will expire on August 2, 2011 as there has been no satisfactory
24 evidence presented that **VESTA INSURANCE CORPORATION** has been
25 removed from said Order of Rehabilitation as required by AS 21.09.070(d) within
26 five years after the date of suspension. Pursuant to AS 21.09.160 (b), this
