1           **GREAT REPUBLIC LIFE INSURANCE COMPANY** fails to meet the  
2 capital and surplus requirement of AS 21.09.070 for the kinds of insurance  
3 authorized.

6           **IT IS HEREBY ORDERED**, pursuant to the provision of  
7 AS 21.09.140 (a) (2) that Certificate of Authority No. F-1179 issued to **GREAT**  
8 **REPUBLIC LIFE INSURANCE COMPANY** to transact the business of  
9 insurance in the State of Alaska shall be suspended until such time as the insurer  
10 has returned to full compliance with Alaska statutes unless terminated sooner as  
11 permitted by statute. Pursuant to AS 21.09.160 (b), this suspension shall  
12 automatically suspend the authority of all of its agents to act as agents of **GREAT**  
13 **REPUBLIC LIFE INSURANCE COMPANY** in this state.

17           **IT IS FURTHER ORDERED**, that during the period of suspension,  
18 **GREAT REPUBLIC LIFE INSURANCE COMPANY** shall not solicit or write  
19 any new business in the State of Alaska but shall file its Annual Statement, pay  
20 fees and any taxes due as provided by AS 21.09.170(b).

25 will continue to be held in safekeeping by **GREAT REPUBLIC LIFE**
