**WHEREAS**, a Certificate of Authority to transact business of insurance in  
the State of Alaska was issued to, **FREMONT LIFE INSURANCE**  
**COMPANY**, domiciled in the State of California.

**WHEREAS**, the Superior Court of California, County of Orange, has  
placed **FREMONT LIFE INSURANCE COMPANY** under an Order of  
Conservatorship, appointing the Insurance Commissioner of the State of  
California as Conservator on June 5, 2008.

1           **WHEREAS**, the Quarterly Statement for the period ending March 31, 2008,  
2 shows that **FREMONT LIFE INSURANCE COMPANY**, fails to meet the  
3 capital and surplus requirements of AS 21.09.070 for the kinds of insurance  
4 authorized.

7           **IT IS HEREBY ORDERED**, pursuant to the provision of AS 21.09.140 (a)  
8 (3) that Certificate of Authority No. F-1327, issued to **FREMONT LIFE**  
9 **INSURANCE COMPANY** to transact the business of insurance in the State of  
10 Alaska shall be suspended until such time as it has returned to full compliance  
11 with Alaska Statutes unless terminated sooner as permitted by statute. Pursuant  
12 to AS 21.09.160 (b), this suspension shall automatically suspend the authority of  
13 all of its agents to act as agents of **FREMONT LIFE INSURANCE**  
14 **COMPANY** in this state.

19           **IT IS FURTHER ORDERED**, that during the period of suspension,  
20 **FREMONT LIFE INSURANCE COMPANY** shall not solicit or write new  
21 business in the State of Alaska, but shall file the annual statement, pay fees and  
22 any taxes due as provided by AS 21.09.170(b).


25           **IT IS FURTHER ORDERED**, that Certificate of Authority No. F-1327
