2 continuation fee by the June 30, 2010 due date as required by AS 21.09.130 (b)
3 and AS 21.09.170 (b).

6 **IT IS HEREBY ORDERED**, pursuant to the provision of AS 21.09.130
7 (b), AS 21.09.140(a)(3) and AS 21.09.200(c) and (e) that Certificate of Authority
8 No. F-10905 issued to **FOX INSURANCE COMPANY** to transact the business
9 of insurance in the State of Alaska shall continue to be held in suspension until
10 such time as it has returned to full compliance with Alaska Statutes unless
11 terminated sooner as permitted by statute. Pursuant to AS 21.09.160 (b), this
12 suspension shall continue to suspend the authority of all of its agents to act as
13 agents of **FOX INSURANCE COMPANY** in this state.

17 **IT IS FURTHER ORDERED** that during the period of suspension **FOX**
18 **INSURANCE COMPANY** shall not solicit or write new business in the State of
19 Alaska but shall file the annual statement, pay fees and any taxes due as provided
20 by AS 21.09.170(b).
