6                   surplus requirements of the State of Alaska under AS 21.09.070 within five years  
7                   after the date of suspension.

9                   **IT IS HEREBY ORDERED**, pursuant to the provisions of AS 21.09.170  
10                  (d), that Certificate of Authority No. F-1179 issued to **GREAT REPUBLIC**  
11                  **LIFE INSURANCE COMPANY** to transact the business of insurance in the  
12                  State of Alaska will expire November 15, 2011. Pursuant to AS 21.09.160 (b),  
13                  this expiration shall automatically revoke the authority of all agents to act as  
14                  agents of **GREAT REPUBLIC LIFE INSURANCE COMPANY** in this state.

16                  **IT IS FURTHER ORDERED**, That Certificate of Authority No. F-1179,  
17                  held in safekeeping by **GREAT REPUBLIC LIFE INSURANCE COMPANY**  
18                  shall be returned to the Alaska Division of Insurance by December 12, 2011.
