**WHEREAS**, a Certificate of Authority to transact the business of insurance in the State of Alaska was issued to **PMI INSURANCE COMPANY**, domiciled in the State of Arizona.

**WHEREAS**, the State of Arizona, Department of Insurance has placed **PMI INSURANCE COMPANY** under an Order for Supervision and Notice of Appeal of Rights on August 19, 2011 with a finding that **PMI INSURANCE COMPANY** is a hazard to its policyholders. The order included the provision

1 that, **PMI INSURANCE COMPANY** cease issuing new mortgage  
2 commitments.

3 **IT IS HEREBY ORDERED**, pursuant to the provisions of AS 21.09.140  
4 (a) (3), that Certificate of Authority No. F-8492 issued to **PMI INSURANCE**  
5 **COMPANY** to transact the business of insurance in the State of Alaska shall be  
6 suspended until such time as it has returned to full compliance with Alaska  
7 Statutes unless terminated sooner as permitted by statute. Pursuant to AS  
8 21.09.160 (b), this suspension shall automatically suspend the authority of all of  
9 its agents to act as agents of **PMI INSURANCE COMPANY** in this state.  
10

11 **IT IS FURTHER ORDERED** that during this period of suspension, **PMI**  
12 **INSURANCE COMPANY** shall continue to file the annual statement and pay  
13 fees and any taxes due as provided by AS 21.09.170 (b).  
14

15 **IT IS FURTHER ORDERED** that Certificate of Authority No. F-8492  
16 will continue to be held in safekeeping by **PMI INSURANCE COMPANY** until  
17 such time as this order is replaced by an Order of Revocation, the Certificate of  
18 Authority is surrendered or the Certificate of Authority expires.
