10 **IT IS HEREBY ORDERED**, pursuant to the provisions of AS 21.09.150
11 (c), that Certificate of Authority No. F-700 issued to **AMERICAN**
12 **MOTORISTS INSURANCE COMPANY** to transact the business of insurance
13 in the State of Alaska shall be suspended until such time as it has returned to full
14 compliance with Alaska Statutes unless terminated sooner as permitted by
15 statute. Pursuant to AS 21.09.160 (b), this suspension shall automatically
16 suspend the authority of all of its agents to act as agents of **AMERICAN**
17 **MOTORISTS INSURANCE COMPANY. IT IS FURTHER ORDERED**
18 that during this period of suspension, **AMERICAN MOTORISTS**
19 **INSURANCE COMPANY** shall continue to file the annual statement and pay
20 fees and any taxes due as provided by AS 21.09.170 (b).
