3 **WHEREAS, AMERICAN MANUFACTURERS MUTUAL**
4 **INSURANCE COMPANY'S** Certificate of Authority has been suspended in the
5 states of North Dakota, Wyoming, Tennessee, North Carolina, Florida, New

9 **WHEREAS, AMERICAN MANUFACTURERS MUTUAL**
10 **INSURANCE COMPANY** is currently in runoff.

13 **IT IS HEREBY ORDERED**, pursuant to the provisions of AS 21.09.150
14 (c), that Certificate of Authority No. F-1080 issued to **AMERICAN**
15 **MANUFACTURERS MUTUAL INSURANCE COMPANY** to transact the
16 business of insurance in the State of Alaska shall be suspended until such time as
17 it has returned to full compliance with Alaska Statutes unless terminated sooner
18 as permitted by statute. Pursuant to AS 21.09.160 (b), this suspension shall
19 automatically suspend the authority of all of its agents to act as agents of
20 **AMERICAN MANUFACTURERS MUTUAL INSURANCE COMPANY.**
21 **IT IS FURTHER ORDERED** that during this period of suspension,
22 **AMERICAN MANUFACTURERS MUTUAL INSURANCE COMPANY**
23 shall continue to file the annual statement and pay fees and any taxes due as
24 provided by AS 21.09.170 (b).
