WHEREAS, a Certificate of Authority to transact the business of insurance
in the State of Alaska was issued to **FINANCIAL GUARANTY INSURANCE**

WHEREAS, the Certificate of Authority issued to **FINANCIAL**
GUARANTY INSURANCE COMPANY to transact the business of insurance
in the State of Alaska was suspended on October 23, 2009 as the company failed

1 to meet the capital and surplus requirements of AS 21.09.070. The suspension
2 was to remain in effect until such time as **FINANCIAL GUARANTY**
3 **INSURANCE COMPANY** had returned to full compliance with Alaska
4 Statutes unless its Certificate of Authority was terminated sooner as permitted by
5 statute.

8 **WHEREAS**, on June 28, 2012, the Supreme Court of the State of New
9 York issued an order placing **FINANCIAL GUARANTY INSURANCE**
10 **COMPANY** in rehabilitation. The Supreme Court of the State of New York
11 subsequently terminated the same order on August 19, 2013.

14 **WHEREAS**, the Quarterly Statement dated September 30, 2013 shows that
15 **FINANCIAL GUARANTY INSURANCE COMPANY** now meets the Capital
16 and Surplus requirements of AS 21.09.070.

19 **IT IS HEREBY ORDERED**, pursuant to the provisions of
20 AS 21.09.170(d) that Certificate of Authority F-1535 issued to **FINANCIAL**
21 **GUARANTY INSURANCE COMPANY**, shall be reinstated, allowing it
22 authority to continue to transact the business of insurance in the state of Alaska.
23 Pursuant to AS 21.09.170(e), this reinstatement shall automatically reinstate the
24 authority of all of its agents to act as agents of **FINANCIAL GUARANTY**
25 **INSURANCE COMPANY** in this state.
