#### **ACCUSATION**

#### ORDER OF DENIAL

Lori Wing-Heier, Director of the Division of Insurance (division), Department of Commerce, Community, and Economic Development (DCCED), State of Alaska, states the issues on which the accusation is based as follows:

1. On or about May 25<sup>th</sup>, 2021, the Alaska Department of Commerce, Community and Economic Development, Division of Insurance (division) issued an Insurance Producer license to transact the business of insurance to Benjamin Roth Robertson (ROBERTSON), domiciled in the State of Texas. The license has an expiration date of January 31<sup>st</sup>, on even numbered years.

- In this initial application, ROBERTSON responded negatively to all background questions regarding administrative action and criminal history.
- 3. At close of business on January 31<sup>st</sup>, 2022, the license expired for failure to renew. ROBERTSON received three renewal notices from the division, dated December 7<sup>th</sup>, 2021, January 6<sup>th</sup>, 2022 and February 5<sup>th</sup>, 2022.
- 4. On November 29<sup>th</sup>, 2022, a reinstatement application was received for ROBERTSON's Insurance Producer license. This application indicates that ROBERTSON has an administrative action in his insurance producer history. The action taken by the state of South Carolina dated November 10<sup>th</sup>, 2020, was not disclosed at initial licensure.

**ROBERTSON** obtained his initial Insurance Producer license in Alaska supplying inaccurate information.

5. AS 21.27.040(a) states that "(a) Application for a license shall be made to the director upon forms prescribed by the director. As a part of or in connection with the application, the applicant shall furnish information concerning the applicant's identity, personal history, experience, business record, purposes, and other pertinent facts that the director may reasonably require. The applicant shall declare, subject to penalty of denial, nonrenewal, suspension, or revocation of a license issued by the director, that the statements made in or in connection with the
