ACCUSATION AND FINAL ORDER

Lori Wing-Heier, Director of the Division of Insurance (Division), Department of
Commerce, Community, and Economic Development (DCCED), State of Alaska, states
the issues on which the accusation is based as follows:

1. On October 11, 2023, **LATISHA VASSEL-BEE (VASSEL-BEE)**,
domiciled in the State of Utah applied for Independent Adjuster license
requesting Property and Casualty authority with the Division to conduct
business in the State of Alaska.
2. Upon review of the application, **VASSEL-BEE** responded negatively to
all background questions, indicating no disclosures to report to the State of
Alaska. During review, it was discovered that **VASSEL-BEE** attached

1 incomplete documentation to the Attachment Warehouse in the form of a
2 written statement documenting misdemeanor and felony convictions. This
3 documentation revealed that **VASSEL-BEE** incorrectly responded
4 negatively to background question 1A at initial application indicating no
5 criminal conviction to report to the Division.

7 3. On October 23, 2023, correspondence was provided to **VASSEL-BEE**
8 informing of her failure to respond accurately to background questions
9 regarding criminal convictions. The Division provided **VASSEL-BEE** the
10 opportunity to voluntarily withdraw the application and provide a new,
11 complete, and accurate application within 30 days. No response was
12 received.

14 4. Alaska Statute 21.27.040(a) states that “(a) Application for a license shall
15 be made to the director upon forms prescribed by the director. As a part of
16 or in connection with the application, the applicant shall furnish
17 information concerning the applicant's identity, personal history,
18 experience, business record, purposes, and other pertinent facts that the
19 director may reasonably require. The applicant shall declare, subject to
20 penalty of denial, nonrenewal, suspension, or revocation of a license
21 issued by the director, that the statements made in or in connection with
22 the application are true, correct, and complete to the best of the applicant's
23 knowledge and belief...”

25 5. AS 21.27.020(a) provides: "For the protection of the people of this state,
26 the director may not issue or renew a license except in compliance with

this chapter and not issue a license to a person, or to be exercised by a person, found by the director to be untrustworthy, incompetent, or who has not established to the satisfaction of the director that the person is qualified under this chapter."

6. AS 21.27.020(b)(4) provides: "To qualify for issuance or renewal of an individual license, an applicant or licensee shall (4) be a trustworthy person."

7. Pursuant to AS 21.27.040(a), **VASSEL-BEE** provided inaccurate information at the time of application. Based on the above **VASSEL-BEE** Independent Adjuster license is hereby DENIED.

ORDER

IT IS HEREBY ORDERED, under the provisions of AS 21.27.040(a) that **LATISHA VASSEL-BEE** application for the Independent Adjuster license in Alaska under National Producer Number (NPN) # 20104209 is DENIED for supplying inaccurate information on the application for licensure.
