ACCUSATION AND FINAL ORDER

Lori Wing-Heier, Director of the Division of Insurance (Division), Department of Commerce, Community, and Economic Development (DCCED), State of Alaska, states the issues on which the accusation is based as follows:

- On December 29, 2023, JASON SCOTT TOLAND (TOLAND),
 domiciled in the State of Alaska applied for his initial Portable Electronics
 Limited Producer license requesting Portable Electronics authority with
 the Division to conduct insurance business in the State of Alaska.
- Upon review of the application, TOLAND responded negatively to background questions number 2, indicating no administrative actions to report to the State of Alaska.

- 3. The Producer Database and Attachment Warehouse reflects administrative action was taken against TOLAND in the State of California in effect January 30, 2020. TOLAND failed to disclose his administrative action to the Division and provided inaccurate information on his application.
- 4. On January 3, 2024, correspondence was provided to TOLAND informing of his failure to respond accurately to a background question regarding administrative actions. The Division provided TOLAND the opportunity to voluntarily withdraw the application and provide a new, complete, and accurate application within 30 days. No response was received.
- 5. AS 21.27.040(a) states that "(a) Application for a license shall be made to the director upon forms prescribed by the director. As a part of or in connection with the application, the applicant shall furnish information concerning the applicant's identity, personal history, experience, business record, purposes, and other pertinent facts that the director may reasonably require. The applicant shall declare, subject to penalty of denial, nonrenewal, suspension, or revocation of a license issued by the director, that the statements made in or in connection with the application are true, correct, and complete to the best of the applicant's knowledge and belief…"
- 6. AS 21.27.020(a) provides: "For the protection of the people of this state, the director may not issue or renew a license except in compliance with this chapter and not issue a license to a person, or to be exercised by a
