ACCUSATION AND FINAL ORDER

Lori Wing-Heier, Director of the Division of Insurance (Division), Department of Commerce, Community, and Economic Development (DCCED), State of Alaska, states the issues on which the accusation is based as follows:

- On January 24, 2024, ABEL SIERRA (SIERRA), domiciled in the State
 of California applied for an Insurance Producer license requesting Life
 authority with the Division to conduct insurance business in the State of
 Alaska.
- Upon review of the application, SIERRA responded negatively to all background questions, indicating no administrative actions to report to the State of Alaska.

- 3. The Producer Database and the Attachment Warehouse reflects administrative action was taken against SIERRA in the State of Wisconsin in effect April 24, 2007, and in the State of California in effect October 21, 2014. Both orders suggest SIERRA has a criminal history.
 SIERRA failed to disclose his administrative actions and criminal history to the Division and provided inaccurate information on his application.
- 4. On February 2, 2024, correspondence was provided to SIERRA informing of the conflicting information reported in the Producer Database and his failure to respond accurately to the background question regarding misdemeanor conviction. The Division provided SIERRA the opportunity to voluntarily withdraw the application and provide a new, complete, and accurate application within 30 days. No response was received.
- 5. AS 21.27.040(a) states that "(a) Application for a license shall be made to the director upon forms prescribed by the director. As a part of or in connection with the application, the applicant shall furnish information concerning the applicant's identity, personal history, experience, business record, purposes, and other pertinent facts that the director may reasonably require. The applicant shall declare, subject to penalty of denial, nonrenewal, suspension, or revocation of a license issued by the director, that the statements made in or in connection with the application are true, correct, and complete to the best of the applicant's knowledge and belief…"
