Hilcorp Alaska, LLC (Hilcorp), by letter dated May 17, 2024, filed an application to the Alaska Oil and Gas Conservation Commission (AOGCC) to establish an allowable gas offtake rate of 1,500 MCF/D for the Milne Point Unit (MPU) to allow sales of compressed natural gas (CNG) to third parties. AS 31.05.030(e)(1)(F) allows the AOGCC to regulate the rate at which oil or gas is withdrawn from a well or field for the purpose of conservation.

Hilcorp is negotiating with Alaska CNG, LLC (AKCNG) to sell CNG from the MPU to AKCNG and possibly additional parties in the future. Selling natural gas from the MPU will reduce the amount of gas available for re-injection into the pools in the MPU for pressure maintenance and enhanced oil recovery (EOR) purposes, which has the potential for reducing ultimate recovery from the field. Hilcorp states the gas reinjection loss can easily be made up by increased water injection, which is the main fluid injected for pressure maintenance and EOR purposes.
