1. Safety Moment, Introduction and Agenda Review – Julie Jessen, HDR

• Julie reviewed the agenda and introduced Sally, Fred and Laurie. She reviewed the ground rules: community's best interest comes first; share the air; address issues; look for the donut, not just the hole; every idea is a good idea.

2. Meeting Purpose, Role of Agency Coordination, Timeline – Sally Russell Cox, DCCED

- The Alaska Community Coastal Protection Project was funded through the federal Coastal Impact Assistance Program (CIAP) by a 2009 grant to the Division of Community and Regional Affairs (DCRA). The project was inspired by the strategic management plan developed for Newtok. The objective of the project is to increase community sustainability and resilience to natural hazard impacts. Essential components of the project are strong community leadership, agency support and careful, effective planning.
- In order to build strong community leadership, a full-time Community Coordinator works to represent the community at these interagency working group meetings, works with project staff, the interagency group, and with the planning contractor to develop a resiliency plan, and advocates for funding to carry out the resiliency plan. DCRA supports the Community Coordinator in carrying out his or her responsibilities, providing technical and other assistance.

- The interagency working group, which consists of federal and state agencies, regional and local organizations, and community representatives, works to coordinate resources and provide technical assistance for implementation of the community resiliency plan.
- HDR was hired to work with the community and interagency working group to develop a strategic management plan for how the community and agencies will proceed over the next 10-20 years to accomplish the actions recommended by the community.
- The plan is community driven with technical support from agencies to sequence activities and projects, identify funding sources, critical funding cycles and resource leveraging opportunities. The interagency group also provides assistance in identification of construction windows. The Interagency Working Group provides coordinated assistance to the community to achieve resilience action. The benefits of the group include leveraging of resources, better work coordination, and reduced project timelines and construction schedule conflicts.

3. Community Welcome and Our Story/Our Values – Fred Eningowuk, Community Coordinator

- Fred discussed the community surveys and noted that there was a good response from the community. He talked about how important it is to hear comments from community elders in particular and how important it is for the community to work together to preserve their traditional way of life and encourage youth to remain in/come back to Shishmaref.
- Fred emphasized the difficulty with even mentioning the word "relocation". He said that it makes it very difficult to get the resources Shishmaref need to maintain and upgrade safe community infrastructure and housing because the view is that if they are going to relocate then there is less interest in investing funds in the community now. Fred expressed some of the community's frustration with the lack of understanding that relocation is a least a decade away and they need resources now and in the future. The community has also expressed frustration with how many studies have been conducted without action or feedback.
- Fred talked about how the community has been adjusting to climate change, pointing out how it has been necessary to move the fish drying racks to avoid the fish being ruined. He also said that the spring bearded seal harvest is down by 50%.

4. Work to Date – Laurie Cummings, HDR

- Laurie summarized the work that has been accomplished to date. The work began with a literature review, community and value surveys, elder interviews and a community gathering. The report from the meeting and information gathered over the last few months is in process. Once the Interagency Working Group meetings have been held and community input has been received, another community gathering will be held. The Strategic Management Plan will be completed in June 2016.
- Laurie discussed the Draft Vision Statement that was developed subsequent to the surveys and community gathering. She noted that it is a work in progress and that it can and should be modified as the process continues. The draft statement summarizes community identified issues and expresses the hope/desire for the future: Shishmaref is a safe and resilient community. We want to relocate to a new village that respects and honors our Inupiaq culture and traditional values. We will work together and with partners to develop projects and policies to protect our residents, infrastructure, natural environment, and subsistence resources. We will preserve and enhance our community for us and future generations.
- Laurie summarized the community issues which are based on the work completed over the last few months: Inadequate and lack of community infrastructure; inadequate housing; lack of jobs and economic development opportunities; need for extension and maintenance of seawall; lack of evacuation shelter/places of refuge; funding; VPSO contact; substance

abuse; children and adult activities; encourage youth to return to Shishmaref after college; need Inupiaq tradition and language classes; alternative energy; elder assistance and youth programs; cost of living; port and more heavy equipment needed.

• Laurie reviewed the community's draft guiding principles: Residents must be safe from natural hazards, flooding and erosion; respect, honor and encourage individual views/ideas; make decisions openly and include local input; encourage local hire and use funds wisely, develop in a manner that strengthens the community and respects Shishmaref's traditional culture

6. Issues and Solutions – Group

Issues:

- Land ownership (NPS) need determination of ownership and park boundaries with the impact of climate change taken into consideration
- USDA has soils information; melting permafrost
- Need climate appropriate, adaptable design
- Need access (maintain) to potential sites
- Need study to evaluate relocation vs. defense -- USACE needs timeline to show budget and schedule for implementation of action items; aging infrastructure needs replacement
- Immediate vs. long term needs; attachment to land and place cultural connection, subsistence; need community and cultural cohesion;
- "Relocation" impact on funding; the word impacts quality of life; negative comparison with communities <u>not</u> relocating
- Need assistance from agencies to develop comprehensive list for base EA/EIS document that will address multi-agency requirements
- Need for moveable/relocatable infrastructure and housing

- Food security-cost and availability; need to address cost of living issues
- Need opportunity to develop and maintain paved roads to improve haul system (upgrade opportunities) sanitation system new infrastructure that can be moved

Solutions/Opportunities/Funding:

- Capacity/organizational support-take advantage of training opportunities for local work force. Will help to encourage youth to stay or return after college if there are local employment opportunities
- Research subsistence, cultural (funding, leverage), coastal dynamics, erosion (NPS)
- NPS Bering Land Bridge; support position on Deer Mountain relocation; have overlapping interests with Shishmaref but has small staff and budget; would support recommendation to Congress for road and land swap. Could provide auxiliary assistance through alignment of research efforts, e.g. subsistence; cultural/social; shipping/oil exploration; fine tune to community desires; "leap frog" relocation rather than a major move.
- Tribal Conservation District
- Lifewater Engineering sewer system for centralized sanitation (mini-system) include lessons learned in document


